

BRIEF EXPLANATION OF LAW NO 6698 PROTECTION OF PERSONAL DATA:

1. Description of the Data Keeping Officer :

Law No. 6698 Protection of Personal Data (KVKK) regulates the principles of how to process, protect personal data and privacy of personal life by real and legal entities. (Greenfit Plastik Metal Yapı Elemanları Üretim Sanayi ve Ticaret Limited Şirketi which will be called "Company") Company is paying utmost attention to the privacy and confidentiality of its employees data, in this respect we are submitting this Brief Explanation about Law 6698 that how we process and protect your data.

2. Scope of Collecting and Processing Personal Data:

3. Transferable Personal Data:

Above mentioned personal data of yours can be transferred and shared with Legal Entities and Institutions such as; Ministry of Labor or Social Security.

4. Method and Legal Cause of Collection of Personal Data:

Your personal data may be collected by our Company through various different channels, also including electronic and physical media, and may be processed for achievement of the purposes described here in above. Depending on the cause requiring you to disclose your personal data to us, your personal data may be processed for such reasons as establishment or management of a contractual relationship, establishment or use of a right, performance of our legal obligations, existence of legitimate interests therein. However, even if any one of these or similar other legal causes is met or satisfied, your personal data may be processed only subject to a prior consent of you.

5. Security of Your Personal Data:

Your personal data within the framework of the law; learning whether it has been processed or not, requesting relevant information; use the purpose of processing and in accordance with these purposes by us learning not to be used; learning third parties to whom it is transferred domestically or abroad; request correction if missing or misused; requiring deletion or destruction of the cause or requesting that in these cases or in case of correction, the third request notification to persons; analysis of processed data exclusively through automated systems object to this situation if you think a result has arisen against you; if you suffer a loss due to unlawful processing, You have the right to request.

Article 20 of the Constitution provides information about have been shown to have the right to be informed about personal data related to his/her work. According to the artical 11 of the KVKKV includes Requesting information amongst is also included amid the rights of the personal data holder Law. In accordance with Article 13 of the Law, requests according to the nature of the request and within 30 (thirty) days at the latest. Process tariff, as required by the Personal Data Protection Board, Shall apply. If the request is rejected, the reason or reasons for the rejection shall be in writing or will be justified in electronic environment.

6. Rights of Personal Data Holder Listed in Article 11 of the Law no. 6698:
